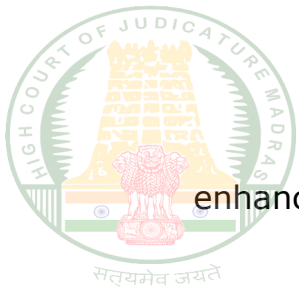

Mr.P.Sathish, learned Additional Government Pleader, takes notice for 1st respondent.

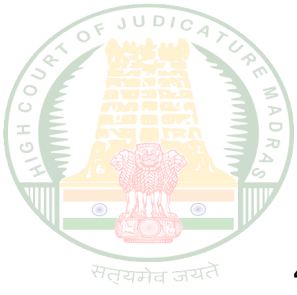
2. It is seen from records that initially the respondent passed an award which was challenged by the petitioner in Arbitration OP No.153 of 2007 before the 1st Additional District Judge, Salem. The learned 1st Additional District Judge through an order dated 27.03.2024 setaside the award and remitted the matter back to the file of the respondent and till date, the respondent has not passed an award.

3. The learned Additional Government Pleader is directed to take instructions. In the meantime, the Project Director, Jagir Ammapalayam, Salem, is suo-motu impleaded as the 2nd respondent in this writ petition and Mrs.S.R.Sumathy, learned standing counsel takes notice for 2nd respondent.

4. Post this case at the end of the motion list on 28.04.2025.

3. When this writ petition was taken up for hearing today, learned Additional Government Pleader produced written instructions received from the first respondent.
