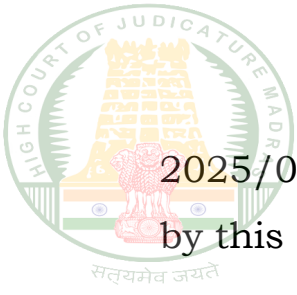

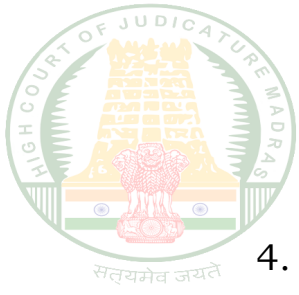

ORDER

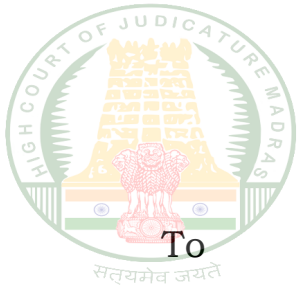
