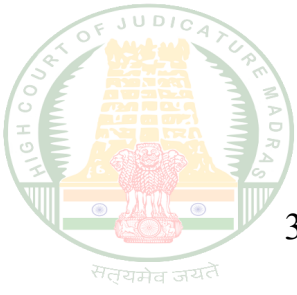

3. When the matter was taken up for hearing, the learned Additional Government Pleader based on the instructions received from the third respondent submitted that the enquiry has been fixed on 11.04.2025 and the claim made by the petitioner will be considered on merits and in accordance with law, and order will be passed within the time frame fixed by the Court.

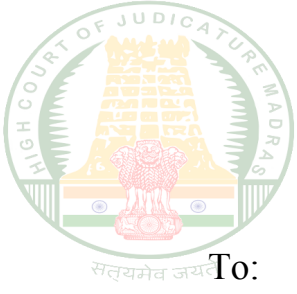
