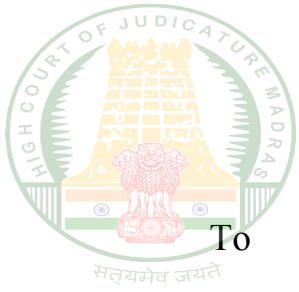
ORDER
