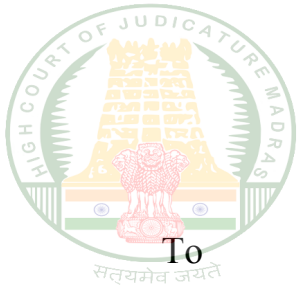
COMMON ORDER
