In view of the orders passed in the W.P.No.7040/23020 and batch., on 31.01.2024, this writ petition has become infructuous.

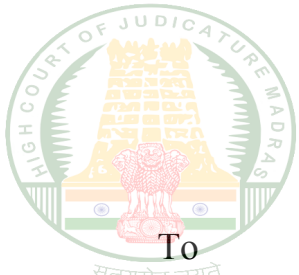
In the result, the Writ Petition is **dismissed** as infructuous. No costs. Consequently, the connected miscellaneous petitions are closed.
