This writ petition has been filed for issue of writ of mandamus directing the 4th and 5th respondents to act upon the online application submitted by the

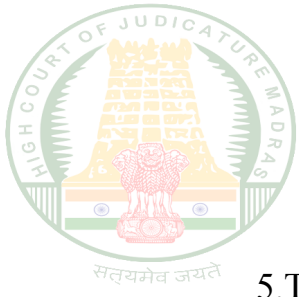
