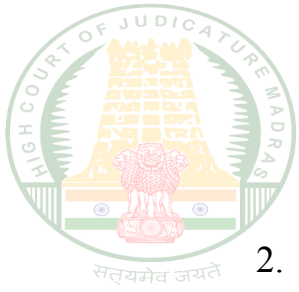
PRAYER
