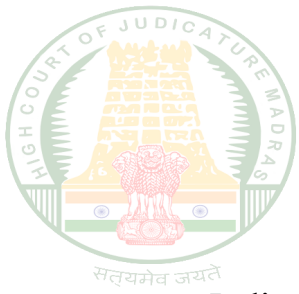

If there are any interested parties, such survey shall be conducted in their presence.

This writ petition is disposed of with the above direction. No costs.
