ORDER

This Criminal Original Petition has been filed by the petitioner, who was arrested and remanded to judicial custody on 05.03.2025, seeking bail in Crime No.77 of 2025 registered for the offence under Sections 3(1), 4(2)(c), 7(1)(a) of ITP Act r/w Sections 336(3), 336(4) of BNS, 2023.

2.It is the case of the prosecution that based on a secret information, the respondent and their officials went to the scene of occurrence and found a girl with two male persons; that on enquiry, it was found that the petitioner along with other accused had conducted prostitution in that place. Hence, the case.

3.The learned counsel for the petitioner would submit that the allegations are false; that based on the confession, the petitioner is sought to be implicated; that co-accused has been released on bail by the lower Court; and that in any case, considering the period of incarceration, further custody of the petitioner is not required and sought for bail.

4.Per contra, the learned Government Advocate (Crl. Side) reiterated the prosecution case and submitted that on the confession of the arrested accused, the petitioner is sought to be implicated.

5.Heard the learned counsel on either side and perused the materials available on record.

6.Considering the nature of allegation, period of incarceration, the fact that the petitioner is sought to be implicated on the confession of co-accused, the fact that the similarly placed co-accused was granted bail by the lower Court, this Court is of the view that further custody of the petitioner is not required for the purpose of investigation. Hence, this Court is inclined to grant bail to the petitioner with certain conditions.

7.Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.15,000/- (Rupees Fifteen Thousand only)** with **two sureties (one surety must be blood relative of the petitioner)**, each for a like sum to the satisfaction of the **Judicial Magistrate, Sriperumbudur**, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[b] the petitioner shall report before the respondent police everyday at 10.30 a.m., until further orders.

[c] the petitioner shall not abscond either during investigation or trial;

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]***;

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
