ORDER

This Writ Petition has been filed for direction directing the fourth respondent to return all original certificates of the petitioner.

2. Heard the learned counsel for the petitioner, the learned Government Advocate for the respondents 1 and 2 and the learned standing counsel for the third respondent and perused the materials available on record.

3. A perusal of records revealed that after completion of his Under Graduation, the petitioner applied for MBA degree in the fourth respondent Institution during the academic year 2022 to 2023. The petitioner was selected and also deposited the admission fee of Rs.10,000/-. At the time of his admission, he had submitted all his original education certificates.
