2. Today, learned counsel for petitioner seeks permission of this Court to withdraw the writ petition.



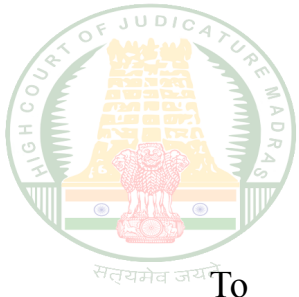
