2. When the matter is taken up for hearing, the learned counsel for the petitioner would submit that the order has since been complied with.

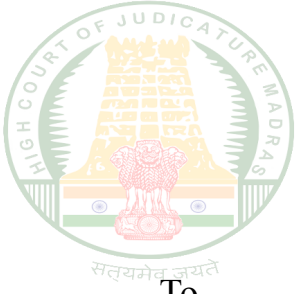
