3. When the matter was taken up for hearing today, the learned

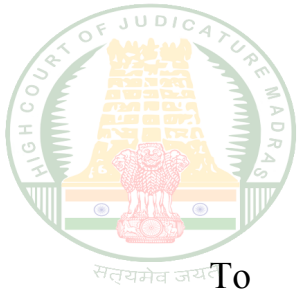
Additional Government Pleader submitted that the application submitted by the petitioner is pending before the second respondent.
