ORDER

On 25.10.2025, the learned counsel for the petitioner submitted that he has given up vakalath in the matter. Thus, this Court directed the matter to be listed on 03.11.2025, to enable the learned counsel for the petitioner to file a memo to the above effect.

2. On 03.11.2025, the learned counsel for the petitioner who had filed writ petition filed a memo informing this Court of he having given up vakalath in the matter.
