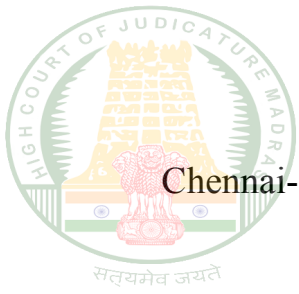

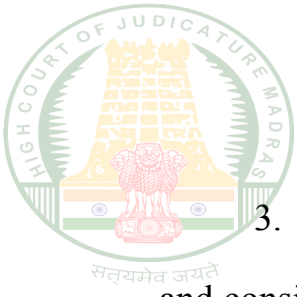

ORDER

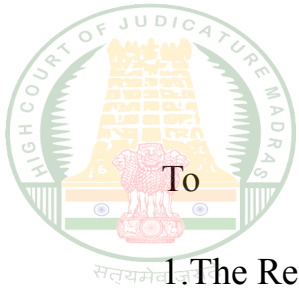
