(Order of the Court was made by Anita Sumanth J.)

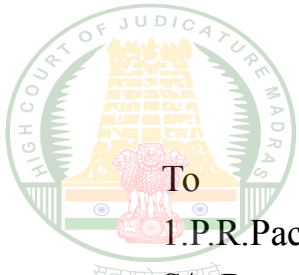
