Prayer : Writ Petition under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus, directing the respondents 3 and 4 to effect corrections in the revenue records such as patta Chitta Adangul etc., with respect to the land in S. No.65/3, measuring 0735 Ares at Thenkumarai village, Thalaivasal Taluk, Salem District, by removing the classification Tharisu and issuing



it in the name of the legal heirs of Chinnangikonar and his deceased son Sekar as per the proceedings in DK6/ 96- 97B4 dated 20.06.1996 of the zonal Deputy Tahsildar No.2, Athur, Salem District and Proceedings in O.Mu. No. 10719716/ 2024/G1 dated 10.01.2025 of the 1st respondent considering the petitioner's representation dated 30.12.2024, sent to the respondents within a stipulated time.

ORDER

3.Taking into consideration the facts and circumstances of the case and considering the materials placed before this Court, there shall be a direction to the 1st



respondent to deal with the representation made by the petitioner on 30.12.2024 on its own merits and in accordance with law and pass final orders within a period of eight weeks from the date of receipt of copy of the order.
