ORDER

The Writ Petition has been filed seeking a direction to the 2nd respondent to consider the application dated 10.03.2023 and to issue computer patta to the petitioner in the light of A-Register of the vacant land comprised in Survey No.72/1, measuring an extent of 0.14.5 ares (36 cents), situated at V.Kumaramangalam Village, Vridachalam Taluk, Cuddalore District.

It is submitted by the learned Government Advocate for respondents that after receipt of the aforesaid application submitted by the petitioner for issuance of computerized patta dated 10.03.2023, the 2nd respondent has now conducted an enquiry and is about to issue patta to the petitioner in respect of the subject land.
