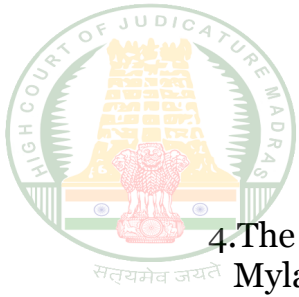

2. In view of the statement made, which is accepted as an undertaking to this Court, Shri Prabakar states that petition can be disposed of.

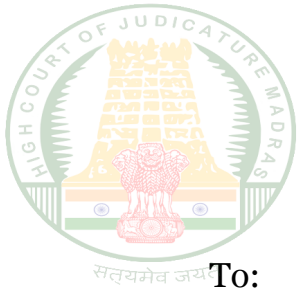
3. Petition is disposed of. There shall be no order as to costs.
