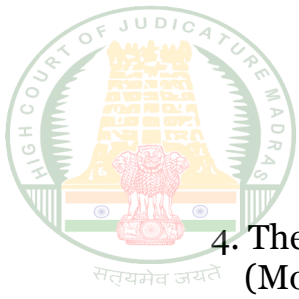

2. Shri Prabakar states within 30 days steps will be taken.

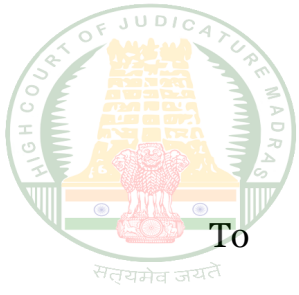
3. Petition is disposed of. There shall be no order as to costs.
