ORDER

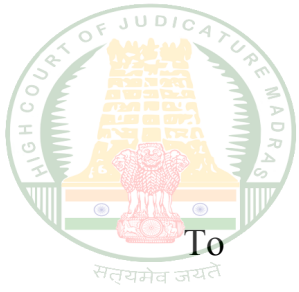
This writ petition is with a prayer to direct the respondents to refund the sum of Rs.5,00,000/- payable to the petitioner towards refundable security deposit.
