earned leave/medical leave salary, within a specified time frame.

The respondents may examine the service register of the petitioner and examine whether any amount is due and payable to the petitioner and if so, pay interest at the rate of 6% per annum from the date of retirement till the date of disbursal. The respondents may also examine whether any amount had been paid with delay and if so, pay interest at the rate of 6% per annum for the said amount from the date of retirement till the date of disbursal. The entire exercise
