2. Heard the learned counsel for the respondents.

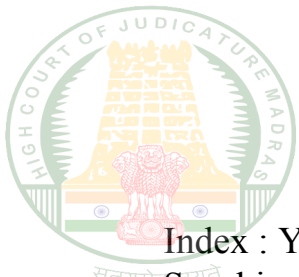

The entire exercise must be completed within a period of six months from the date of receipt of a copy of this order.
