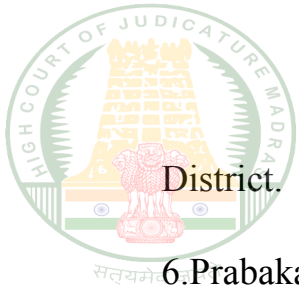

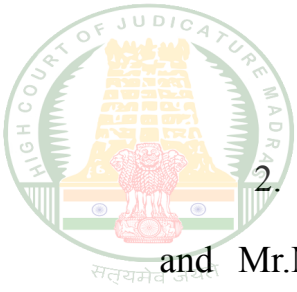
PRAYER

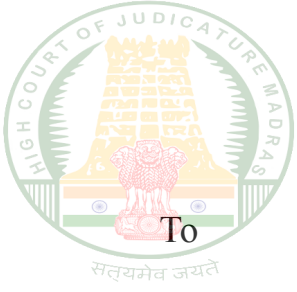
