3. The petitioner lodged a complaint before the Judicial Magistrate No.I, Karaikal and sought for a direction under Section 156(3) of Cr.P.C. The learned Judicial Magistrate No.I, Karaikal, by an order dated 31.01.2024, directed the respondent to conduct an enquiry, if a cognizable offence is made out, to register the FIR. However, so far, the respondent has not completed the preliminary enquiry.
