2. When the matter was taken up for hearing, the learned counsel for the petitioner sought permission of this Court to withdraw this Civil Revision Petition and made the following endorsement:

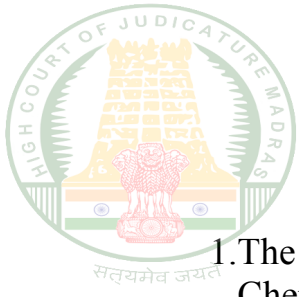
"The premises may be completely vacated and handed over on or before 31.10.2025. Hence, this Revision Petition may be permitted to be withdrawn as it has become infructuous."
