ORDER

This Criminal Original Petition has been filed by the petitioner, who was arrested and remanded to judicial custody on 11.03.2025, seeking bail in Crime No.182 of 2025 registered for the offence under Sections 126(2), 296(b), 132 and 351(3) of BNS, 2023 and Section 3 r/w 5 of TN Open Places (Prevention of Disfigurement) Act, 1959.

2.It is the case of the prosecution that on 27.02.2025, while the respondent and their officials were on security duty on the funeral ceremony of the deceased, the petitioner, who is the wife of the deceased along with the other accused stuck posters on the walls at Sathya Nagar which was printed with offensive words; that when the respondent questioned the same and tried to stop them, the accused abused the respondent in filthy language and threatened them. Hence, the case.

3.The learned counsel for the petitioner would submit that the petitioner is innocent; and that in any case, the petitioner is in custody from 11.03.2025 and hence, further custody is not required and sought for bail.

4.Per contra, the learned Government Advocate (Crl. Side) reiterated the prosecution case and submitted that there are ten previous cases pending against the petitioner and she is on bail in those cases.

5.Heard the learned counsel on either side and perused the materials available on record.

6.Considering the nature of allegations, period of incarceration, the fact that the petitioner is on bail in the previous cases and since further custody of the petitioner is not required for the purpose of investigation, this Court is inclined to grant bail to the petitioner with certain conditions:

7.Accordingly, the petitioner is ordered to be released on bail on her executing a bond for a sum of **Rs.15,000/- (Rupees Fifteen Thousand only)** with **two sureties**, each for a like sum to the satisfaction of the **V Metropolitan Magistrate, Egmore, Chennai**, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[b] the petitioner shall stay at Kancheepuram District and report before the Inspector of Police, Taluk Police Station, Kancheepuram, everyday at 10.30 a.m., until further orders;

[c] the petitioner shall not abscond either during investigation or trial;

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]***;

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
