This Writ Petition has been filed challenging the Denial Order No. Na. Ka. No.C1/6359/2023 dated 05.04.2023 issued by the first respondent, thereby rejected the request made by the petitioner to conduct the Eruthu Vidum Vizha (Bull Leaving Festival).

2. The representation submitted by the petitioner seeking permission and protection to conduct “Eruthu Vidum Vizha” (Bull Leaving Festival) was rejected, on the ground the petitioner did not produce the relevant Government Order along with the application to conduct the Eruthu Vidum Vizha (Bull Leaving Festival).
