Considering the submissions of both sides and the nature of the offence, the condition in paragraph no.8(b) imposed on the petitioner in CrI.O.P.No.30840 of 2024 dated 09.01.2025 and subsequently modified in CrI.M.P.No.4709 of 2025 in CrI.O.P.No.30480 of 2024 dated 14.03.2025 is now modified to the effect that **the petitioner shall report before the respondent police, once a month, i.e., on the first Monday of every month at 10.30 a.m., until further orders.**
