Writ Petition is filed under Article 226 of the Constitution of India

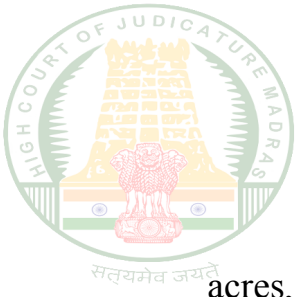
