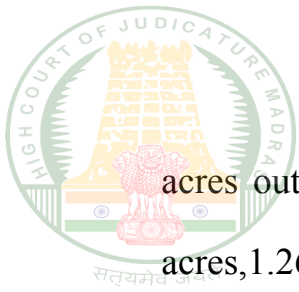

PRAYER

Writ petition filed under Article 226 of Constitution of India for the issue of writ of Mandamus directing the 1st respondent herein to consider the representation of the petitioner dated 15.02.2025 sent for rectifying the error occurred during UDR scheme in respect of the Petitioner's lands measuring 1.68



acres out of 5.47 cents, 0.74 1/2 acres out 2.25 acres, 0.29 acres out of 5.06 acres, 1.26 acres out of 4.22 acres, 0.06 acres out of 0.14 acres, 0.96 acres out of 1.59 acres, 0.14 1/2 acres out of 1.76 acres, 0.40 acres out of 3.01 acres and 0.20 acres out of 1.17 acres in S.F.No.34,35,41,56,153/2,154/1,199/1A,200 and 202 situate at Nakondapalli village, Hosur Taluk, Krishnagiri District and to issue patta in his name in accordance with law and within a stipulated period and pass orders.

ORDER

to the 1st respondent to deal with the representation made by the petitioner on 15.02.2025 on its own merits and in accordance with law and pass orders after affording an opportunity to all the interested parties, within a period of eight weeks from the date of receipt of a copy of this order.

4. This writ petition is disposed of with the above directions. No costs.
