Instead of filing a suit against the person who is interfering with the peaceful possession and enjoyment of the petitioner's property, the petitioner submitted a representation seeking police protection for his property. Therefore, police protection cannot be granted to the property, and as such, the representation submitted by the petitioner cannot be considered, and the Writ Petition is devoid of merits.

4. Accordingly, this Writ Petition is dismissed. No costs.
