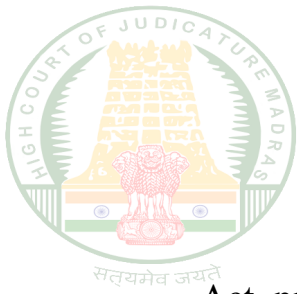

ORDER

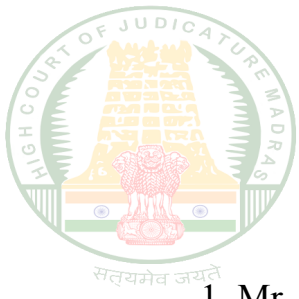
The learned counsel for the petitioner, as well as the learned counsel appearing for the respondents submitted that the order passed by the Writ Court has been complied with.
