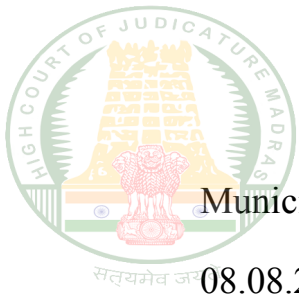

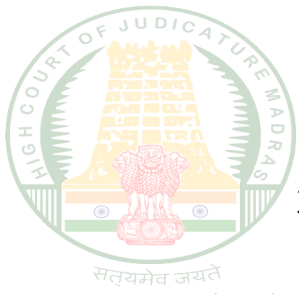

No costs. Consequently connected miscellaneous petition is closed.

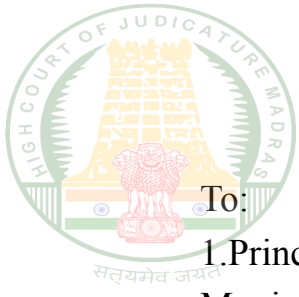
