Therefore, this Court is not inclined to entertain this revision. Accordingly, the Civil Revision Petition stands dismissed with liberty to the petitioners to move



the Sessions Judge under Section 29 of the Domestic Violence Act. No costs.

Consequently, connected Miscellaneous Petition is closed.
