3. Recording the said submission, the Writ Petition stands closed. There shall be no order as to costs.

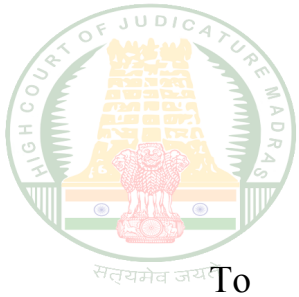
