Counsel for petitioner sought leave to withdraw the petition.

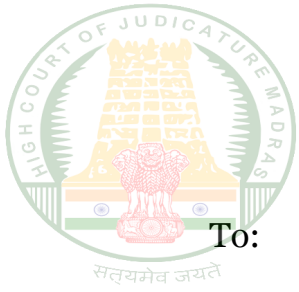
2. Petition is dismissed as withdrawn. There shall be no order as to costs.
