4. This Writ is disposed of with the above direction. No costs.

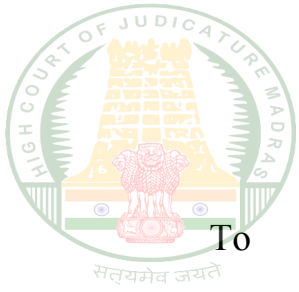
