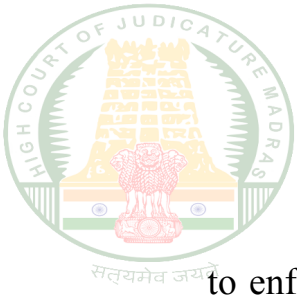

WEB COPY Prayer: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus directing the respondents 1 & 2 to recover Rs.98,658/- as on 30.04.2016 and the loan dues payable as per the monthly demands of the petitioner Society from the monthly salary and other service benefits payable to the 5th respondent now working under the 2nd respondent, who stood as Surety to the loan availed by the deceased Mr.T.Natrayan and the 1st respondent from the terminal benefits of Mr.T.Natrayan towards the loan availed by him from the petitioner Society and remit the same to the petitioner Society, direct the 1st & 2nd respondents to pay the cost for this action, grant such reliefs as expedient to the facts and circumstances of the matter.

ORDER

to enforce such payment. The jurisdiction of a Writ Court under Section 226 is extremely narrow, particularly on issues relating to contract and agreement.

3. Accordingly, the writ petition stands dismissed. No costs.
