ORDER

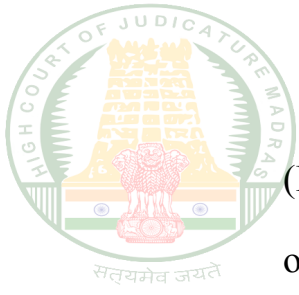
Today, the matter is listed under the caption "for being mentioned", at the instance of the learned counsel for the petitioner.
