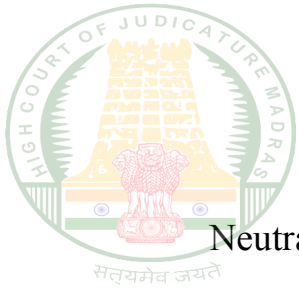
3.Accordingly, this petition is dismissed.

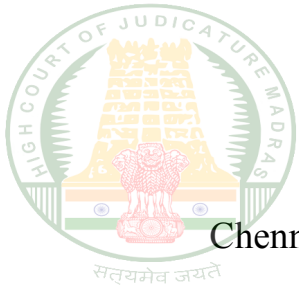
