4. Considering the submission made and on being satisfied with reasons stated in the affidavit, this Court is of the view that the delay may be condoned, however, on payment of cost. Accordingly, the delay is condoned on payment of cost of Rs.500/- (Rupees Five Hundred only) each, by the petitioner to the Tamilnadu Legal Aid Services Authority, Chennai, on or before 20.08.2025. On payment of cost, the Registry is directed to number the main appeals and post the same for admission on 22.08.2025. If the cost is paid on or before 20.08.2025, these petitions stand allowed. If the cost is not paid on or before 20.08.2025, these C.M.Ps. stand dismissed without any reference to this Court.
