4. The learned counsel for the petitioner submitted that it will suffice if the survey is conducted in S.No.306/42. Hence, the survey shall be confined to this Survey Number. If there are any other interested parties, such survey shall be conducted in their presence.

5. This writ petition is disposed of with the above directions. No Costs.

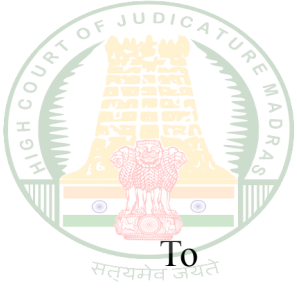
