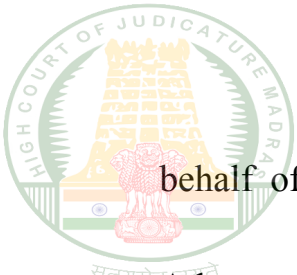

Once such an application is made, the 1st respondent shall act upon the same and take a decision with respect to the survey of the subject property, within a period of four weeks thereafter. If there are any other interested parties, such survey shall be conducted in their presence.
