ORDER

The petitioner seeks modification of condition no. 1(iii), directing him to appear before the respondent police station daily at 10.00 a.m. for a period of 30 days in [CrI.M.P.No.12090](#) of 2024, dated 03.10.2024.

2. Learned counsel for the petitioner submitted that condition no. 1(iii) imposed by the trial Court in [CrI.M.P.No.12090](#) of 2024 dated 03.10.2024 could not be complied with because he was appearing before the Principal Special Court under the EC and NDPS Act, Salem, as ordered by this Court in [CrI.O.P.No.24487](#) of 2024 dated 23.10.2024; and that the said condition has now been relaxed by this Court in [CrI.M.P.No.3409](#) of 2025 dated 27.02.2025 and the petitioner may be permitted to appear before the respondent police as ordered by the trial Court.

3. Accordingly, **the petitioner is directed to appear before the respondent police daily at 10.30 a.m. for a period of two weeks and thereafter before the Principal Special Court under the EC and NDPS Act, Salem, once a week, i.e., on every Monday at 10.30 a.m., until further orders.**
