The learned counsel for the appellant has filed a memo stating that the respondent – Employees State Insurance Corporation on 24.07.2025, has introduced an Amnesty Scheme for the purpose of one time settlement of all the disputes pending as on 31.03.2025.

3. The said memo is taken on record. The appellant is permitted to withdraw this appeal in order to avail the benefit of Amnesty Scheme as mentioned supra.

Recording the aforesaid submissions, this Civil Miscellaneous Appeal stands dismissed as withdrawn with liberty to file the Appeal afresh in the event of the appellant's case is not considered as per the New Amnesty Scheme dated 24.07.2025. There is no order as to costs. Consequently, connected miscellaneous petition is closed.
