This Criminal Original Petition has been filed by the petitioner to set aside the order dated 14.03.2023 passed in C.M.P.No.7177 of 2023 in S.T.C.No.296 of 2019 on the file of the Judicial Magistrate No.1, Udumalpet.

Today, when the matter is taken up for hearing, the learned counsel for the petitioner submitted that the respondent filed a complaint against the petitioner under Section 138 of the Negotiable Instruments Act in S.T.C.No.296 of 2019 on the file of the Judicial Magistrate No.1, Udumalpet and pending case, the petitioner filed a petition in C.M.P.No.7177 of 2023 invoking Section 91 Cr.P.C. for production of specimen signature of the petitioner found in his bank account opening form to compare the same with the disputed cheque and obtain expert opinion, but the same was dismissed by order date 14.03.2023, against which, the present Criminal Original Petition was filed before this Court.
