5.In view thereof, nothing survives for adjudication in this Writ

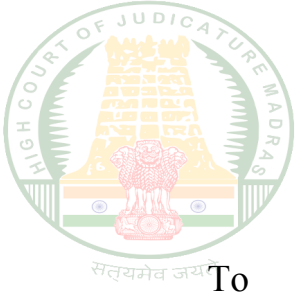
