“To direct the 2nd respondent to register the new sale deed in respect of the petitioners property more



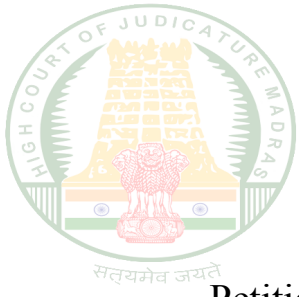

2. A counter has been filed by the 1st respondent. In paragraph No.iv of the counter affidavit, the 1st respondent has stated that the subject property has not been provisionally attached.
